## Watch Out!!

Children are using digital media more and more. We regularly remind you to be cautious when allowing children to use tablets, iPads etc. and whilst we are all aware of the more obvious dangers of say social media sites, it is worth highlighting the hidden dangers that we could easily overlook!

Below is a link to an article that has brought to light a concern that even the most vigilant practitioner/parent/carer could miss. Whilst the article details alarming misuse of the Peppa Pig animation, this method could be utilised in many ways to target a vulnerable audience.

Some choose not to allow children to access these devices whilst in their care, but that's not to say we that there isn't more you can do to support parents and children themselves to be more vigilant.

Things to consider;

- Be conscious of parental restrictions on devices.
- View media before allowing children access.
- Regularly monitor/supervise children when streaming videos etc.
- Restrict opportunities for streaming data to times that can be supervised.



### LSCB Audits

The LSCB regularly carry out audits of the work undertaken within a serious case review. From this they publish a report that details the key findings from the review and what lessons we can learn.

To keep the sector informed, we will share these audits with you via electronic mail out. Please look out for the information and be sure to review your safeguarding practice, taking on board key messages and advisable next steps.
