

Leicester City Council Short Breaks Duty Statement



Introduction

Welcome to the Leicester City Council Short Breaks Duty Statement. Under the Children and Young People's Act, local authorities are required to provide short breaks for families with disabled children. This duty, which came into effect on April 1, 2011, mandates that each local authority produce a short breaks statement. The statement outlines the services available and how the range of short breaks are designed to meet the specific needs of families with disabled children living in Leicester.

What is a Short Break statement?

The Leicester City Council Short Breaks Duty Statement is intended for professionals and families who support or care for disabled children aged 0-19 years residing in Leicester City. This statement offers information about available short break services, and how to access them.

The Short Breaks Duty is a legal obligation for all local authorities to provide a variety of short breaks for disabled children. It also requires the Local Authority to publish a Short Breaks statement. This document has been developed following consultations with the Leicester City Parents' and Carers' Forum, The Big Mouth Forum, and a city-wide electronic consultation involving the local authority, health services, education, and the voluntary sector.

What is a short break?

A short break is any activity that gives a child or young person a fun and positive experience, away from their parents or carers. It helps them socialise, make friends, and spend time with supportive carers, while also giving their parents or carers a much-needed break. Short breaks can happen after school, on weekends, during school holidays, or overnight.

These breaks can take place in the child or young person's own home, in a community setting, or at a building-based service. A short break could involve joining a group activity like a club or doing something on their own, supported by an approved carer or personal assistant.

Examples of short break activities include after-school clubs, youth clubs, sports, drama groups, adventure playgrounds, play schemes, and holiday clubs.

Overnight short breaks are planned stays for children and young people with complex needs or behavioural difficulties. These stays help parents and carers get a break and can take place in a Leicester City Council residential home or with a Family Link carer, following an assessment.

What is a disability?

All young people in Leicester City with a disability are entitled to receive a short break. For this statement, we have used the definition of disability from the Disability Discrimination Act to ensure compliance with the Disability Discrimination Acts 1995 and 2005, as well as the Equality Act 2010

A person with:

"a physical or mental impairment which has a substantial and long term adverse effect on his ability to carry out normal day to day activities", (Equality Act 2010).

Who can access short breaks?

Many Short Breaks available within Leicester City can be arranged by contacting the provider directly without the need for any assessment. However, for some children and young people, an assessment may be necessary to ensure that support is tailored to their individual needs. This process helps ensure resources are distributed fairly and targeted to where they are most needed.

What is the Local Offer?

The Leicester City Local Offer is a website that provides information about support and services available in Leicester for children and young people with Special Educational Needs or Disabilities (SEND). It brings together all the information parents and carers need in one place, helping families understand what services they can expect from local agencies, including early years settings, health, education, and social care. The range of services in Leicester

The services are offered at three different levels:

Universal services

Universal services are available to all young people who reside in Leicester City whether they have a disability or not. There is no need for an assessment to access these services as you can contact them directly. These services include after school clubs, leisure centres, youth clubs, adventure playgrounds, sports clubs, and organisations such as Cadets, Brownies and Scouts.

Early Help services

Early Help services are services delivered by charities and voluntary sector organisations and can be accessed by contacting the organisers directly.

Some services are specifically set up and run for children and young people with additional needs - these are called targeted services. A few of these services are delivered directly by Disabled Children's Service following an assessment: for example, the Gardening Club.

Specialist services

Some families may require a higher level of support. Specialist services are available through a formal assessment by the Disabled Children's Service Support Worker, who will evaluate the impact of the child's or young person's disability on family life.

The services provided will be tailored to meet the specific needs of the child or young person and their family. This may include homecare support or Direct Payments. Direct Payments are funds allocated to parents to purchase their own support services to meet assessed needs for their child. Parents often use this money to hire an agency carer or personal assistant to help their child access activities in the community or at home.

Support for Short Break Service Providers

The Disabled Children's Service offers a range of support and guidance to all Short Break Providers. This support includes:

- Free Training on a range of disability issues
- Support for behavioural issues from Behavioural Inclusion Service
- Personal Assistant Register, where details of availability of people who would undertake Direct payment work can be accessed at <u>families.leicester.gov.uk/disabled-childrens-service/personal-assistants</u>

'Supporting Me' forms can be used for by other providers to detail the support and risk assessment for each child or young person.

Transport

Generally, it is the responsibility of parents and carers to provide transport to and from short breaks. As part of the short breaks provision, the Disabled Children's Service follows Leicester City Council's policy to encourage green transport. To support this, we are working with staff from various organisations to become Independent Travel Trainers. This will help young people learn how to travel independently to their chosen short breaks.
